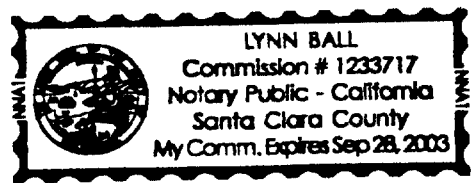

PARCEL 1
