KNOW ALL BY THESE PRESENTS that Michael E. Long

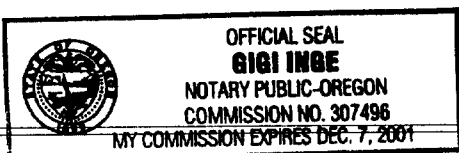
