Cornelius & Diana** hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

Lot 5, Block 4, Plat of The Town of Doten situated in Section 31, Township 39 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon.

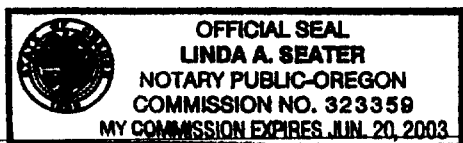
