WHEREAS, Eugene Frizzell entered into an agreement with Klamath County on August 14, 1997, for the purchase of real property described as:

The SE% of the NE% of Section 22, Township 35 South, Range 11 East of the Willamette Meridian, Klamath County, Oregon. SUBJECT TO Covenants, conditions, reservations, easements, restrictions, rights, rights of way and all matters appearing of record.

WHEREAS, the property was purchased for the sum of \$3,000.00 and a down payment of \$750.00 was made the day of the sale and the sum of \$652.50 was paid as the first annual installment due August 14, 1998; and

WHEREAS, on December 8, 1998, Eugene Frizzell passed away. On or around January 26, 1999, the law office of Brad Aspell representing the Estate of Eugene Frizzell contacted Property Sales Dept. regarding the status of the agreement. On August 3, 1999, a notice was mailed regular and certified to the law office for payments for the 1998 taxes and the August 14, 1999, annual installment as required by Sections 2 and 3 of the Land Sale Agreement. The payments are now in default under the terms of the Land Sale Agreement; and

WHEREAS, on November 22, 1999, a letter was mailed regular and certified to the law office requesting the annual installment in the amount of \$672.36 and the 1998 taxes be paid in full by December 27, 1999. A return receipt to Klamath County Property Sales Department was received on November 23, 1999; and

WHEREAS, a final notice was mailed regular and certified on January 3, 2000, requesting the remaining balance, interest and recording fee in the amount of \$2,048.24 plus the 1998 taxes be paid by January 7, 2000; and

WHEREAS, no payment has been made and the Land Sale Agreement is now in **Default**.

NOW, THEREFORE, IT IS HEREBY ORDERED, that the Land Sale Agreement between Klamath County and Eugene Frizzell dated August 14, 1997, is hereby declared null and void. A certified copy of this Order shall be served as summons is served by the Sheriff to the law offfice of Brad Aspell for the Estate of Eugene Frizzell at 122 S. 5th Street, Klamath Falls, OR 97601.

NOTE: Pursuant to ORS 275.220 (2) within twenty (20) days after the service of the order of cancellation upon the holder, the holder of the canceled contract may appeal from such order to the circuit court for the county in which the land is located. The appeal shall be tried by the court as an action not triable by right to a jury. If appeal is not so taken or if it results upon trial in an affirmance of the order of cancellation, such order shall become absolute and the real property so forfeited again may be sold, without notice.
