right to enter upon the lands of the undersigned, situated in the
County of KLAMATH, State of Oregon, and more particularly
described as follows: W_{1/2} AND S_{1/2} SECTION 36 TWP 23S RANGE 10 E
A SUBDIVISION OF SAID COUNTY CALLED SUN FOREST ESTATES

and to construct, operate and maintain on the above described lands,
an electric transmission or distribution line or system, at a loca-
tion(s) on said property as follows: PRIMARY LINE ALONG ALL ROADS AND
DOWN ALL PROPERTY LINES SERVICE DROPS TO ALL LOTS

and to cut and trim trees and shrubbery that may interfere with or
threaten or endanger the operation and maintenance of said line or
system.

The undersigned agrees that all poles, wires and other facili-
ties, installed on the above described lands at the Cooperative's
expense shall remain the property of the Cooperative, removable at
the option of the Cooperative, upon termination of service to or on
said lands.

The undersigned covenant that THY ARE, the owner of the above
described lands and that said lands are free and clear of encum-
brances and liens of whatsoever character, except those held by the
