WHEREAS, on the matter before the Klamath County Board of Commissioners it appears that certain parties holding an interest in the seven properties shown below were not served notice of foreclosure during the redemption periods. The properties were included in the Foreclosures as shown.

Parcel 1: R-3509-014A0-02900 - Lot 9, Block 4, Lone Pine On The Sprague, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon. Included in Foreclosure No. 88-1-FR and deeded to Klamath County on January 4, 1991, in Volume M91, Page 143 and rerecorded on April 22, 1991, in Volume M91, Page 7274.

Parcel 7: R-3510-01900-01700 - The SW $\frac{1}{4}$ SE $\frac{1}{4}$ SE $\frac{1}{4}$ NW $\frac{1}{4}$ and the W $\frac{1}{2}$ E $\frac{1}{2}$ NE $\frac{1}{4}$ SW $\frac{1}{4}$ lying North of Sprague River Highway in Section 19, Township 35 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon. Included in Foreclosure No. 87-1-FR and deeded to Klamath County on August 7, 1990, in Volume M90, Page 15746.

NOW THEREFORE, it is ordered that the above described properties are removed from the foreclosure deeds recorded in Volume M91, Page 143 and rerecorded in Volume M91, Page 7274, Volume M94, Page 23672, Volume M95, Page 10567, Volume M92, Page 22320, Volume M98, Page 439674, Volume M96, Page 15717 and Volume M90, Page 15746.

IT IS FURTHER ORDERED, that the Judgments and Decrees for Foreclosure Nos. 88-1-FR, 90-1-FR, 91-1-FR, 89-1-FR, 95-1-FR, 92-1-FR and 87-1-FR are still effective.
