<ol> <li>All wells shall be securely covered to prevent any foreign substance from entering the well.</li> <li>All wells shall be equipped with an access port or airline so that static water level information can be determined at any time.</li> <li>Well casing must be protected from damage and meet minimum extension requirements.</li> <li>Wells may only be permanently abandoned by a licensed and bonded well constructor or a landowner with a valid permit and bond. Well abandonment</li> </ol>
must be carried out in accordance with state rules.
