THIS AGREEMENT made and entered into on April 12, 2000, by and between I.F. Rodgers & Sons, hereinafter called the first party, and Rodgers Family Limited Partnership, Their Heirs and assigns, hereinafter called the second party, WITNESSETH:

WHEREAS: The first party is the record owner of the following described real property in Klamath County, State of Oregon, to-wit:

The West 33 feet of Lot 2, all that portion of Lot 2, lying Southwesterly of the right of way of the United States Government Canal "F". Lots 3, 4, 5, 6, 11, 12, 13 and 14 of Section 4; Lots 9, 10, 15, and 16 of Section 5; all in Township 40 South, Range 11 East of the Willamette Meridian.

and has the unrestricted right to grant the easement hereinafter described relative to the real estate.

NOW, THEREFORE, in view of the premises and in consideration of \$ 1.00 by the second party to the first party paid, the receipt of which is acknowledged by the first party, it is agreed:

The first party hereby grants, assigns and sets over to the second party an easement, to-wit:

A Right Of Way Easement on existing Road for ingress, egress and utility purpose. Beginning at the intersection of Webber Road and Northwest 60 feet of Lots 4, 5, and the corner of Lot 12 Section 4, Northeast 60 feet of Lot 9 and 16 Section 5 to the entry of Lot 17; all in Township 40 South, Range 11 East of the Willamette Meridian.

The second party shall have all rights of ingress and egress to and from the real estate (including the right from time to time, except as hereinafter provided, to cut, trim and remove trees, brush, overhanging branches and other obstructions) necessary for the second party's use, enjoyment, operation and maintenance of the easement hereby granted and all rights and privileges incident thereto.

Except as to the rights herein granted, the first party shall have the full use and control of the above described real estate.

The second party agrees to save and hold the first party harmless from any and all claims of third parties arising from the second party's use of the rights herein granted.

The period of this easement shall be Perpetual, always subject, however, to the following specific conditions, restrictions and considerations:

If this easement is for a right of way over or across the real estate, the center line of the easement is described as follows:

Thirty feet from the Lots 4 and 5 west boundry fence and thirty feet from the edge of the existing road on the west corner of Lot 12 Section 4; the West 30 feet of existing road Lots 9, 16 of Section 5; all in Township 40 South and Range 11 East of the Willamette Meridian.

and the second party's right of way shall be parallel with the center line and not more than \_\_\_\_\_ feet distant from either side thereof.

This agreement shall bind and inure to the benefit of, as the circumstances may require, not only the parties hereto but also their respective heirs, executors, administrators, assigns, and successors in interest.

In construing this agreement, where the context so requires, the singular includes the plural and all grammatical changes shall be made so that this agreement shall apply equally to individuals and to corporations. If the undersigned is a corporation, it has caused its name to be signed and its seal, if any, affixed by an officer or other person duly authorized to do so by its board of directors.

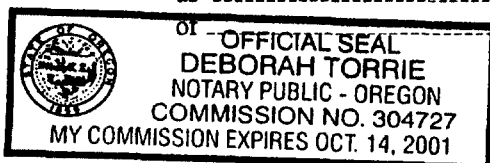

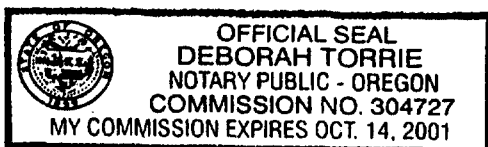

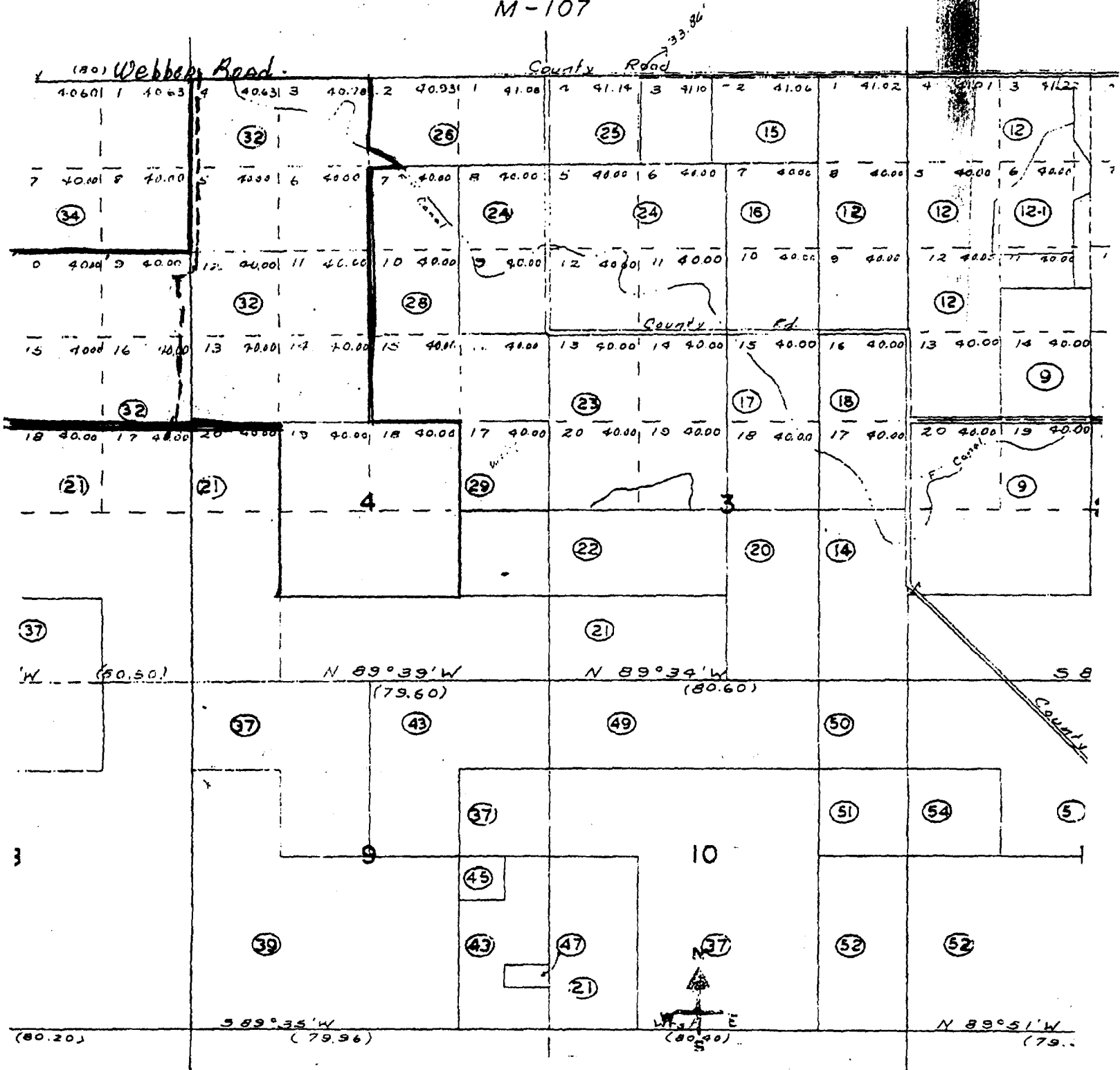
