MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE (this "Memorandum") is made as of March 28, 2000, by and between Melvin Charles Hendrickson and Virginia Kay Hendrickson, as trustees of the Melvin Charles Hendrickson and Virginia Kay Hendrickson 1992 Revocable Living Trust (collectively "Lessor"), and Driscoll Strawberry Associates, Inc., a California corporation ("Lessee").




