EXHIBIT "A"
LEGAL DESCRIPTION

The most Easterly 90 feet of portion of NE1/4 NE1/4 of Section 10, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at an iron pin on the Westerly right of way line of Summers Lane which lies South 89 degrees 40' West 30 feet and North 1 degree 12' West along said Westerly right of way line 1225.9 feet from an iron pin in the center of Summers Lane that marks the Southeast corner of NE1/4 NE1/4 of Section 10; thence continuing North 1 degree 12' West along said Westerly right of way line 72.7 feet to an iron pin; thence South 89 degrees 40' West 240 feet to a point; thence South 1 degree 12' East 72.7 feet to a point; thence North 89 degrees 40' East 240 feet, more or less, to a point of beginning.
