Description of Property

A portion of the SW of Section 17, Township 24 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

All of that portion of the SWi of Section 17, Township 24 South, Range 7 East of the Willamette Meridian.
