NOTICE OF DEFAULT AND ELECTION TO SELL

Reference is made to that certain trust deed made by Douglas A. Bergman, Sr. and Dorothy L. 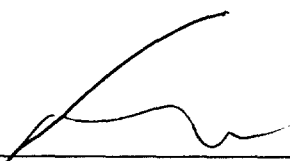

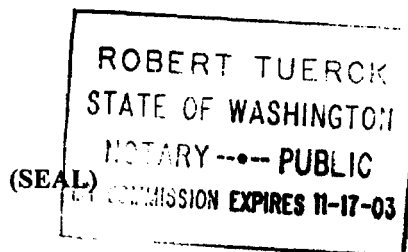
