EXHIBIT "A" DESCRIPTION OF PROPERTY

That portion of the NW ¼ SE ¼ NE ¼ of Section 28, Township 34 South, Range 7 East of the Willamette Meridian, in the County of Klamath, State of Oregon, lying Westerly of State Highway 97 and Easterly of a dirt road, being more particularly described as follows:
