

### IT IS HEREBY DECREED THAT:

- (1) The marriage of the parties is hereby dissolved and said dissolution is finally effective April 25, 1983.
- (2) Petitioner is awarded the care, custody and control of MENDY JEAN OGLESBY, whose date of birth was February 27, 1981, subject to Respondent's reasonable visitation right to see appropriate to the control of Mendy Jean Oglesby.
- (3) Respondent is awarded the care, custody and control of TARON RAE OGLESBY, whose date of birth was March 1, 1982, subject to Petitioner's reasonable visitation right to see and visit Taron Rae Oglesby.
