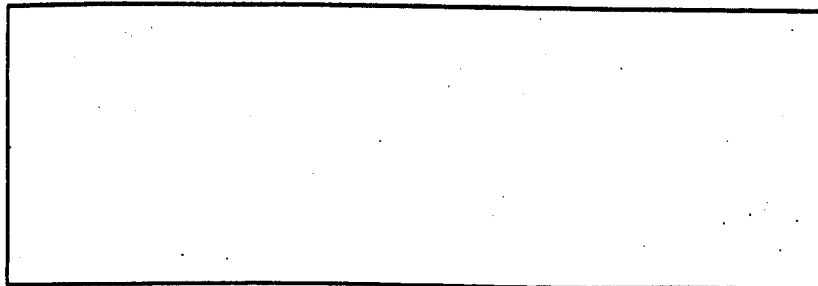
As of MARCH 2000 , the obligor owes unpaid support in the amount of

THIS MATTER came on for trial on the 30th day of  
December, 1982. Petitioner appeared in person and by and through  
his attorney, Michael L. Brant; Respondent appeared in person and  
by and through her attorney, Arthur A. Beddoe.

THE COURT FINDING, after testimony of the parties and  
their witnesses, that irreconcilable differences exist between  
the parties making continuation of the marriage relationship  
impossible and that the parties were married on July 15, 1980, in  
Klamath County, Oregon, and that two children were born during  
the marriage, namely, Mendy Jean Oglesby, whose date of birth was  
February 27, 1981, and Taron Rae Oglesby, whose date of birth was  
March 1, 1982, and the Court further finding that the parties  
separated on or about the 27th day of August, 1982, and further  
finding that there is no equity, which is an asset of the  
marriage in the business known as "Jeff's Pitt Stop", and by  
stipulation of the parties, each of the parties have relinquished  
all of their respective claims to interest in said business; now,

1 therefore,

2 IT IS HEREBY DECREED THAT:

3 (1) The marriage of the parties is hereby dissolved and  
4 said dissolution is finally effective April 25, 1983.

5 (2) Petitioner is awarded the care, custody and control  
6 of MENDY JEAN OGLESBY, whose date of birth was February 27, 1981,  
7 subject to Respondent's reasonable visitation right to see and  
8 visit Mendy Jean Oglesby.

9 (3) Respondent is awarded the care, custody and control  
10 of TARON RAE OGLESBY, whose date of birth was March 1, 1982,  
11 subject to Petitioner's reasonable visitation right to see and  
12 visit Taron Rae Oglesby.

13 (4) There is no child support awarded to either party.

14 (5) Petitioner shall pay each month for a period of  
15 nine months, commencing April 1, 1983, the sum of \$250.00 as a  
16 contribution to the support of Respondent. All support payments  
17 herein ordered shall be made through the Clerk of the Circuit  
18 Court, Klamath County Courthouse, Klamath Falls, Oregon.

19 (6) Neither party is responsible for the debts of the  
20 other incurred after the commencement of the separation date,  
21 which was August 27, 1982.

22 (7) The parties shall each be awarded the personal  
23 property that each had in his own or her own possession as of the  
24 date of the hearing, which was December 30, 1982, and each party  
25 shall be responsible for any encumbrance on any item of personal  
26 property in his own and her own possession, holding the other


1 party harmless therefrom, except that Petitioner is awarded the  
2 1982 Honda automobile, subject to any encumbrance, holding  
3 Respondent harmless therefrom, and that Respondent is awarded the  
4 Subaru automobile, subject to any encumbrance, holding Petitioner  
5 harmless therefrom.

6 (8) The real property of the parties, described as Lot  
7 41, LAMRON HOMES, Klamath County, Oregon, shall be sold, with the  
8 net proceeds first to pay the medical bills and if any proceeds  
9 are remaining after the medical bills are paid, then the debt in  
10 the sum of \$2,711.00 owed to Lois Macy shall be paid. In the  
11 event there are any remaining proceeds after these debts are paid  
12 in full, then such remaining proceeds shall be divided between  
13 Petitioner and Respondent.

14 (9) The parties shall be responsible for their own  
15 attorney's fees and costs.

16 (10) Each party shall inform the Clerk of the Circuit  
17 Court of any change of his or her address within ten days of such  
18 change.
