

**RELINQUISHMENT OF RESERVATION**

**WHEREAS**, the UNITED STATES OF AMERICA, acting by and through the Forest Service, Department of Agriculture, pursuant to the General Exchange Act of March 20, 1922 (42 Stat. 465, as amended; 16 U.S.C. 485, 486) and the Federal Land Policy and Management Act of October 21, 1976, as amended (90 Stat. 2743; 43 U.S.C. 1715, 1716, 1717), conveyed certain lands in T. 24 S., R. 10 E., T. 24 S., R. 11 E., and T. 25 S., R. 9 E., Willamette Meridian by Patent No. 36-99-0009 and Bureau of Land Management Quitclaim Deed No. 36-99-D0003, issued to Crown Pacific Limited Partnership by the Bureau of Land Management, Department of the Interior, signed February 5, 1999, and recorded June 8, 1999 in Vol. M99, page 22521 and signed February 5, 1999, and recorded June 8, 1999 in Vol. M99, page 22544 respectively, Klamath County records.

**WHEREAS**, said Patent and Quitclaim Deed contained the following reservation by the United States.

The right for itself and third parties to remove any and all timber under specific timber sale contracts, until termination of said contracts; including extensions thereof, and any other contracts necessary to effect removal of such timber in the following timber sale:

Windsock LP Salvage, contract 070873, with Tom Harmon Logging, dated 8/5/96.

**WHEREAS**, said patent and quitclaim Deed also included the following language:

The United States shall, at Crown Pacific Limited Partnership's request, release its reserved timber rights prior to termination of the timber sale contract as the harvest of the reserved timber and post harvest slash disposal and erosion control measures are completed. The release shall be a document in recordable form to Crown Pacific Limited Partnership or its successors or assigns in interest.

**WHEREAS**, all harvest activities and other actions under the Windsock LP Salvage Timber Sale have been completed.
