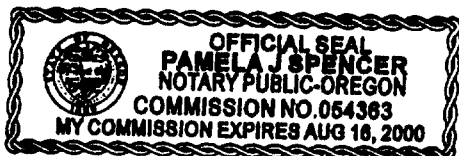
The undersigned hereby covenants to and with the assignee that the undersigned is the beneficiary or beneficiary's successor
