the County Clerk of Klamath County, Oregon, containing 0.14 acres more or less.

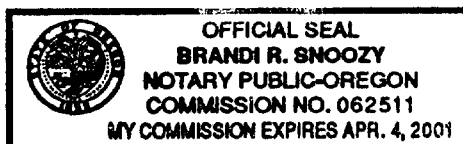
