Section 2: That part of Section 2 lying Southwesterly of the Klamath Falls-Lakeview Highway No. 66. EXCEPTING THEREFROM the parcel deeded to J. C. Harrison, et ux., by deed recorded in Book 166 at Page 293, Deed Records of Klamath County, Oregon. ALSO EXCEPTING that part of the 100 foot logging railroad right of way of

of Klamath County, Oregon. ALSO EXCEPTING that part of the 100 foot logging railroad right of way of Weyerhaeuser Company lying Northwesterly of a point which is North 19 degrees 47' East 2,871.74 feet from the Southwest corner of said Section 2, and FURTHER EXCEPTING the 66 foot logging road right of way of Weyerhaeuser Company described in Book 324 at Page 157, Deed Records of Klamath County, Oregon, and FURTHER EXCEPTING that parcel conveyed from Owen R. Watts and Virginia M. Watts to Richard J. Smith by Warranty Deed dated September 21, 1971 and recorded September 22, 1971 in Book M-71 at Page 10078, Microfilm Records of Klamath

County, Oregon.

Section 3: A portion of the SE 1/4 SW 1/4 and the SE 1/4, more particularly described as follows:

Beginning at a 5/8 inch iron pin in the Section line between Sections 3 and 10 from which the quarter corner common to said Sections 3 and 10, a brass cap, bears South 89 degrees 43' 28" East 105.00 feet; thence North 08 degrees 17' 00" East 465.00 feet to a 5/8 inch pin; thence North 57 degrees 21' 00" East 2402.00 feet to a 5/8" iron pin; thence North 13 degrees 01' 13" West 820.23 feet to a 5/8 inch iron pin; which is the Southwest corner of that parcel of land conveyed in Book 134 at Page 419, Deed Records of Klamath County, Oregon; thence North to the East-West centerline of said Section 3; thence East along said centerline to the East line of said Section 3; thence South along said East line to the Southeast corner of Section 3; thence North 89 degrees 43' 28" West along the South line of said Section 3 to the quarter corner common to Sections 3 and 10; thence continuing along said South line of Section 3, North 89 degrees 43' 28" West 105.00 feet to the point of beginning.
