ORDER FOR IMPROVEMENT # 2000-070

WHEREAS, a petition to improve **Kings Way** situated in the S1/2 NW1/4 of Section 18, Township 39S., Range 10 E.W.M., Klamath County, Oregon was presented to the Board of Commissioners, and

WHEREAS, said petition was executed by the property owners in accordance with ORS 371.615, and

WHEREAS, the Board of County Commissioners did refer said petition to the County Engineer for his report, and

WHEREAS, the County Engineer did find said project to be feasible, and

WHEREAS, the Board of County Commissioners did cause to be mailed, a written notice of the favorable report and the estimated cost of the improvement to each of said property owners, calling for remonstrances against the said project, and




WHEREAS, less than the required 50% remonstrances were received from the abutting property owners;

NOW THEREFORE IT IS HEREBY ORDERED pursuant to the provisions of ORS 371.635 that **Kings Way**, situated in the S1/2 NW1/4 of Section 18, Township 39S., Range 10 E.W.M., Klamath County, Oregon, be improved by contract; said improvement to be with an asphalt paved surface 24-feet in width, 4-foot graveled shoulders, drainage facilities as required, and reconstruction of driveway entrances where they exist at the time of construction;

IT IS FURTHER ORDERED that the land abutting on said street improvement is subject to a lien of an assessment for the cost of said improvement in an amount to be determined later by Order of the Board of County Commissioners.

IT IS FURTHER ORDERED that this Order shall be recorded and indexed in the Bond Lien Docket in the office of the Klamath County Clerk.
