MODIFICATION OF DEED OF TRUST

THIS MODIFICATION OF DEED OF TRUST IS DATED JUNE 8, 2000, BETWEEN Oregon Pacific Petroleum Company, Inc. dba: American Pacific Petroleum (referred to below as "Grantor"), whose address is 32910 VanDuyn Rd., Eugene, OR 97408; and Pacific Continental Bank (referred to below as "Lender"), whose address is P.O. Box 10727, Eugene, OR 97440.

DEED OF TRUST. Grantor and Lender have entered into a Deed of Trust dated June 1, 1997 (the "Deed of Trust") recorded in Klamath County, State of Oregon as follows:

Recorded July 11, 1997 as Volume M97, on Page 21847, in Official Records of Klamath County, State of Oregon.

REAL PROPERTY DESCRIPTION. The Deed of Trust covers the following described real property (the "Real Property") recorded in Klamath County, State of Oregon:

MODIFICATION. Grantor and Lender hereby modify the Deed of Trust as follows:

Extend maturity date from June 1, 2000 to June 1, 2001.

DEFINITIONS: The following word(s) shall have the following meaning(s) when used in this Deed of Trust.

NOTE: The word "Note" now means the Promissory Note dated June 8, 2000 in the original amount of \$700,000.00 from Oregon Pacific Petroleum Company, Inc. dba: American Pacific Petroleum to Lender, together with all renewals, extensions, modifications, refinancings, consolidations, and substitutions for the note or credit agreement. This note is given in substitution for the Promissory Note dated June 1, 1999.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification but also to all such subsequent actions.
