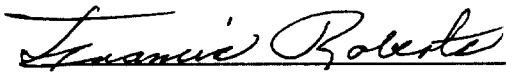
Lot 25, Block 15, Klamath Forest Estates, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

In Witness Whereof the said vendor has executed this Memorandum June 28, 2000.

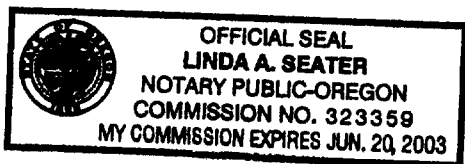
