In Witness Whereof the said vendor has executed this Memorandum June 28, 2000.

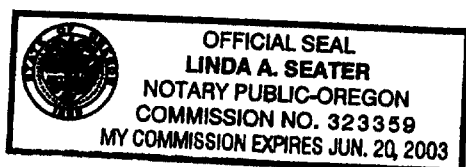
