WATER LINE EASEMENT

Shirley Faye Hilyard, Kelly Anne Hilyard, Hal Gregory Hilyard, and Shanna Leann Hilyard, Grantors, convey to the Klamath Community College Service District, a municipal corporation, Grantee, an Easement for the installation, maintenance, and repair of a water line more particularly described below, over, on, and under the Easement heretofore granted by Warranty Deed recorded February 21, 1975 in Volume M75 Page 2133 of the Deed Records of the Clerk of Klamath County, Oregon and which Easement is described as Parcel 2 on said Deed. This Easement shall be limited to the installation of a water line and the requisite meter anti-flow back valves and other improvements required by the City of Klamath Falls for the attachment of the waterline to the City's domestic water mainline.

By virtue of this Easement, Grantee shall have the right to go upon the real property described above for the purpose of constructing and installing on said property a domestic water line to serve Grantee's land which is located immediately south of said parcel. Grantee shall indemnify and hold Grantor harmless from any claims of liability or damage arising or resulting from Grantee's said use of the subject premises.


