# MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE ("Memorandum") is executed this 7th day of Febluary, 2000, by and between James R. Lancaster and Janice R. Lancaster, an estate in fee simple as tenants by the entirety; ("Landlord"), whose mailing address is HC30 Box 145. Chemult. Oregon 97731, and American Tower, L.P., a Delaware limited partnership ("Tenant"), whose mailing address is 501 Canal Boulevard, Suite E, Point Richmond, California 94804.

WHEREAS, Landlord and Tenant executed and entered into a Lease Agreement (the "Lease") dated 1, 2000, for the purpose of installing, operating, sublicensing and maintaining a communications facility and other improvements on the Property (as hereinafter defined).

WHEREAS, the parties wish to provide a memorandum of the lease, to supplement the description of the Property (as hereinafter defined) and to provide for a commencement date under the Lease.

NOW, THEREFORE, in consideration of the Lease and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Landlord and Tenant hereby agree as follows:

- 1. <u>Lease Term.</u> The terms of the Lease shall be five (5) years commencing on not later than the first day of June, 2001 or the start of construction, whichever first occurs (the "Commencement Date"), and terminating at midnight on the fifth anniversary of the Commencement Date (the "Initial Term"). Tenant has the option under the terms of the Lease to extend the Lease for five (5) additional five (5) year terms (the "Renewal Terms").
- 2. <u>Property</u>. Subject to the terms of the Lease, as may be amended from time to time, Landlord has leased to Tenant the real property described on Exhibit "A" attached hereto (the "Property") and Landlord has granted unto Tenant, for the Initial Term and any Renewal Term, easements for ingress, egress and utilities over that real property also described in Exhibit "B" attached hereto (collectively the "Easements").
- 3. Notices. All notices, requests, demands, and other communications to Landlord or Tenant shall be made at the addresses for each as set forth above, unless otherwise notified in writing.


