WHEREAS, by resolution, heretofore adopted, the common council of the City of Chiloquin, Oregon, upon it's own investigation and initiation found that it is in the best interest of the public that a street right of way located on the east end of Chinchalo from Lalo to the river in said City should be vacated and did by said resolution fix the hour of 6:00 pm of the 26th day of OCTOBER, 1999 and the council chambers in the City Hall of said City, as the time and place when a public hearing would be held at which objections and remonstrances made in writing and filed with the City Recorder for said City, or made by the public at said meeting, would be heard and considered: which hearing was duly held; and affidavit of posting notices of said hearing being also filed herein; and no objections or remonstrances having been filed or offered at said hearing; and a certificate of the City Recorder being filed herein to the effect that the property to be vacated is a dedicated street right of way and as such there are no unpaid city liens or taxes against it, and it appearing to the Common Council that the market value of the property abutting the

THEREFORE. THE CITY OF CHILOQUIN, OREGON DOES ORDAIN AS FOLLOWS:

## Section 1.

portion of said right of way to be vacated will not be

substantially affected by the vacation:

That a street right of way described as the east end of Chinchalo from Lalo to the river is hereby vacated, except that the City of Chiloquin reserves the right to enter upon said right of way or any portion thereof at any future time for the purpose of installing and/or maintaining water lines, sewer lines, or other utility lines if necessary.

## Section 2

The City Recorder is hereby directed to file certified copies of this ordinance with the following offices, to wit; the County Clerk of Klamath County, Oregon, for recording in deed records, the Assessor and Surveyor of said Klamath County, for use in their respective offices.
