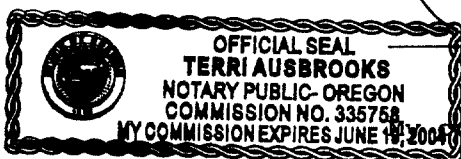

**EXHIBIT "A"**  
**LEGAL DESCRIPTION**

**PARCEL 1:**

That portion of Lots 1 and 2, Block 50, NICHOLS ADDITION TO THE CITY OF KLAMATH FALLS, OREGON, in the County of Klamath, State of Oregon, more particularly described as follows:

Beginning at the most Easterly corner of said Lot 1; thence Southwesterly along the Southeasterly line of said Lots 1 and 2 a distance of 90 feet; thence Northwesterly at right angles to said Southeasterly line of said Lots 1 and 2 a distance of 50 feet; thence Northeasterly and parallel to said Southeasterly line of said Lots 1 and 2 a distance of 90 feet; thence Southeasterly along the Northeasterly line of said Lot 1, 50 feet to the point of beginning.

**PARCEL 2:**

All that part of Lots 1 and 2 in Block 50 of NICHOLS ADDITION TO THE CITY OF KLAMATH FALLS, OREGON in the County of Klamath, State of Oregon, more particularly described as follows:

Beginning at a point 86 feet Northwesterly from the most Southeasterly corner of Lot 1, Block 50, NICHOLS ADDITION TO KLAMATH FALLS, OREGON; thence Northwesterly along the Westerly line of Eleventh Street 30 feet; thence Westerly at right angles to Eleventh Street 90 feet; thence Southeasterly parallel with Eleventh Street 30 feet; thence Northeasterly at right angles to Eleventh Street 90 feet to the place of beginning.

**PARCEL 3:**

A tract of land in Lots 1 and 2, Block 50, NICHOLS ADDITION TO THE CITY OF KLAMATH FALLS, in the County of Klamath, State of Oregon, described as follows:

Beginning at the point on the Southerly line of Eleventh Street which is 50 feet Northwesterly along the Southerly line of Eleventh Street from the most Easterly corner of Lot 1 mentioned above; thence Southwesterly and parallel to Washington Street (formerly Canal Street) 90 feet; thence Northwesterly and parallel to Eleventh Street 36 feet; thence Northwesterly parallel to Washington Street (formerly Canal Street) 90 feet to the Southerly line of Eleventh Street; thence Southeasterly along the Southerly line of Eleventh Street 36 feet to the point of beginning.
