ASSUMPTION AGREEMENT WITH RELEASE

THIS AGREEMENT is made August 17, 20000 between Jesus V. Reyes and Maria G. Reyes (GRANTOR), Jesus V. - 3. FUNDS FOR TAXES AND INSURANCE. GRANTOR hereby relinquishes and transfers to GRANTEE all GRANTOR'S interest in any moneys which may be held by LENDER as escrow deposits for the purposes of application of taxes, assessments, fire or other insurance premiums, or any other purposes for which deposits are being required by LENDER. GRANTEE assumes the liability for payment of any unpaid taxes, assessments, fire or other insurance and agrees to continue making monthly deposits for such purposes as required by LENDER.
- 4. LENDER CONSENT AND RELEASE. LENDER hereby consents to the sale and transfer of such property to GRANTEE by GRANTOR, hereby accepts GRANTEE as its obligor, and shall amend its records to indicate the transfer of such indebtedness from the name of GRANTOR to the name of GRANTEE, and LENDER shall henceforth in all respects treat GRANTEE as its Grantor. LENDER hereby releases GRANTOR from all obligations or liabilities under such Note or Deed of Trust. All other terms of this agreement to the contrary notwithstanding, the remedies contained in paragraph 17 of the Deed of Trust shall remain in full force and effect in accordance with their terms.
