WARRANTY DEED

KNOW ALL BY THESE PRESENTS that Bill W. and Tracey E. Middlebrooks

That portion of lot 16, Block 6; situated North and East of a point 1230 feet South and 415 feet east of the Northwest corner of said lot 16, Block 6, Klamath Falls Forest Estates Subdiv Unit, also described as lot 16B, Block 6, Subdiv Unit, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.


