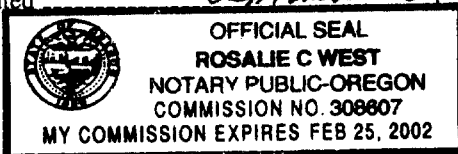
Lots 4 and 5 in Block 6 of JACK PINE VILLAGE, Klamath County, Oregon
