

MEMORANDUM OF LAND SALE AGREEMENT



In Witness Whereof the said vendor has executed this Memorandum October 3, 2000.

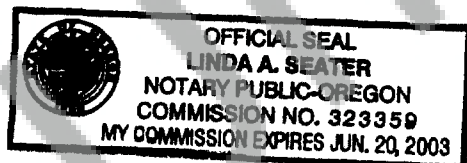
