The provisions set forth in this Memorandum shall not be used in interpreting the Lease. In the event of a conflict between any provisions of the Lease and any provision of this Memorandum, the Lease shall control.
- 4. This Memorandum may be executed in any number of counterparts, each of which shall constitute an original, and is intended to be recorded in the Real Property Records of Klamath County, Oregon.


