This communication is an attempt to collect a debt. Any information obtained will be used for that purpose.

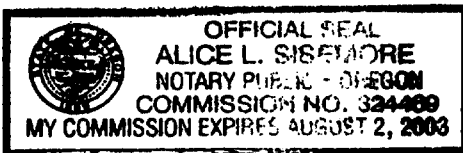
