BARGAIN AND SALE DEED

KNOW ALL BY THESE PRESENTS that ROBERT J. BOGATAY & MELVIN L. STEWART

hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto

WESGO, a partnershiphereinafter called grantee, and unto grantee's heirs, successors and assigns, all of that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

A tract of land situated in the SE $\frac{1}{4}$ of Section 16, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, being more particularly described as follows:

Beginning at the 1/4 corner common to Section 21 and said Section 16; thence N00°23'30" East, along the North-South center section line of said Section 16, 2660.43 feet to the center 1/4 corner of said Section 16; thence N89°54'43" East, along the East-West center section line of said Section 16, 700.65 feet to a point on the Southwesterly right of way line of the Union Pacific Railroad; thence S33°30'54" East, along the said Southwesterly right of way line, 2237.31 feet; thence, along the Southerly line of those lands described in Deed Volume 43, page 548 of the Klamath County Deed Records, S45°54'05" West 333.50 feet, S50°55'55" West 645.28 feet and S22°38'06" West 173.70 feet to a point on the South line of said Section 16; thence S89°50'25" West 1147.05 feet to the point of beginning.

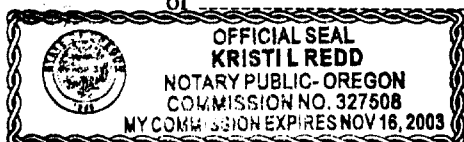
