Grantor irrevocably grants, bargains, sells and conveys to trustee in trust, with power of sale, the property in Klamath County, Oregon, described as:

- 3. To comply with all laws, ordinances, regulations, covenants, conditions and restrictions affecting said property, including all applicable building
- 4. To provide and continuously maintain insurance on the buildings now or hereafter erected on the property against loss or damage by fire and such other hazards as the beneficiary may require, in an amount not less than the evaluate-ed assessment of the house including the renovation costs with Such heneficiary policies of insurance shall be delivered to the beneficiary through their agent, SoCO beneficiary designated on said policies.
