WHEREAS Owner is the owner of the following described zeal property:

WHEREAS, Owner desires to develop a medical office building and parking area; and

WHEREAS, this development will contribute to the need for, as well as benefit from, the following improvements:

Construction, to City Standards, sidewalks, curbs, gutters, streetlights and paved streets within the Cros by Avenue right-of-way and a pedestrian connection from the building entrance to the public sic ewalk; and

WHEREAS, a condition of the Owner's land use approval from the City for development of the Property is agreement to participate in the cost of said future improvements

## NOW THEREFORE, THE PARTIES HERETO AGREE AS FOLLOWS:

- 1. In the event and at such time as the City initiates the formation of a Local Improvement District (LID) for the funding and construction of sidewalks, curbs, gutters, streetlights and paved streets in the Cros by Avenue right-of-way, Owner agrees to not remonstrate against the formation of such LID.
- 2. The City agrees that a LID assessment levied against the Owner's Property shall not exceed the benefit conferred upon the Property
- 3. Owner agrees to install a pedestrian walkway from the main building entrance to the public sidewalk within 120 days of the public sidewalk installation.
- 4. This agreement shall run with the Property and shall bind and inure to Owner's successors in interest.
