**TERMINATION OF EASEMENT**

WHEREAS, on May 6 1991, the United States of America, acting by and through the Forest Service, Department of Agriculture as Grantor, executed an easement for a road across certain land in Klamath County, Oregon, to Crown Pacific Limited Partnership, successor in interest to Gilchrist Timber Company as Grantee, which deed is recorded in the public records of Klamath County, Oregon, in Book M-94 of Deeds at page 8436, and Agreement to Correct Deed dated 4/19/1995 and recorded May 1, 1995 in Book M-95 at page 11121 reference to said easement and the record thereof is hereby made for a more complete description of said easement and the terms thereof; and

WHEREAS, for good and valuable consideration, Crown Pacific Limited Partnership, successor in interest to Gilchrist Timber Company, Grantee, by joining in the execution of this document, consents to the termination of said easement; and

WHEREAS, said easement provided that the Chief, Forest Service, may terminate the easement or any portion thereof by consent of the Grantee;

NOW THEREFORE, the United States of America, by the Forest Supervisor, Fremont/Winema National Forest, pursuant to the delegation of authority by the Regional Forester, Pacific Northwest Region, 58 F.R. 30766, published May 27, 1993, does hereby terminate the said easement.

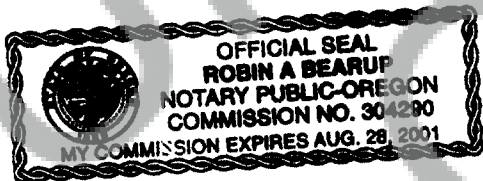

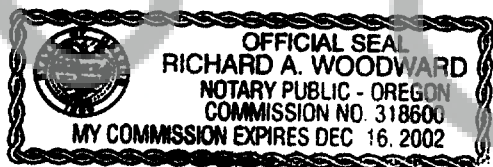
