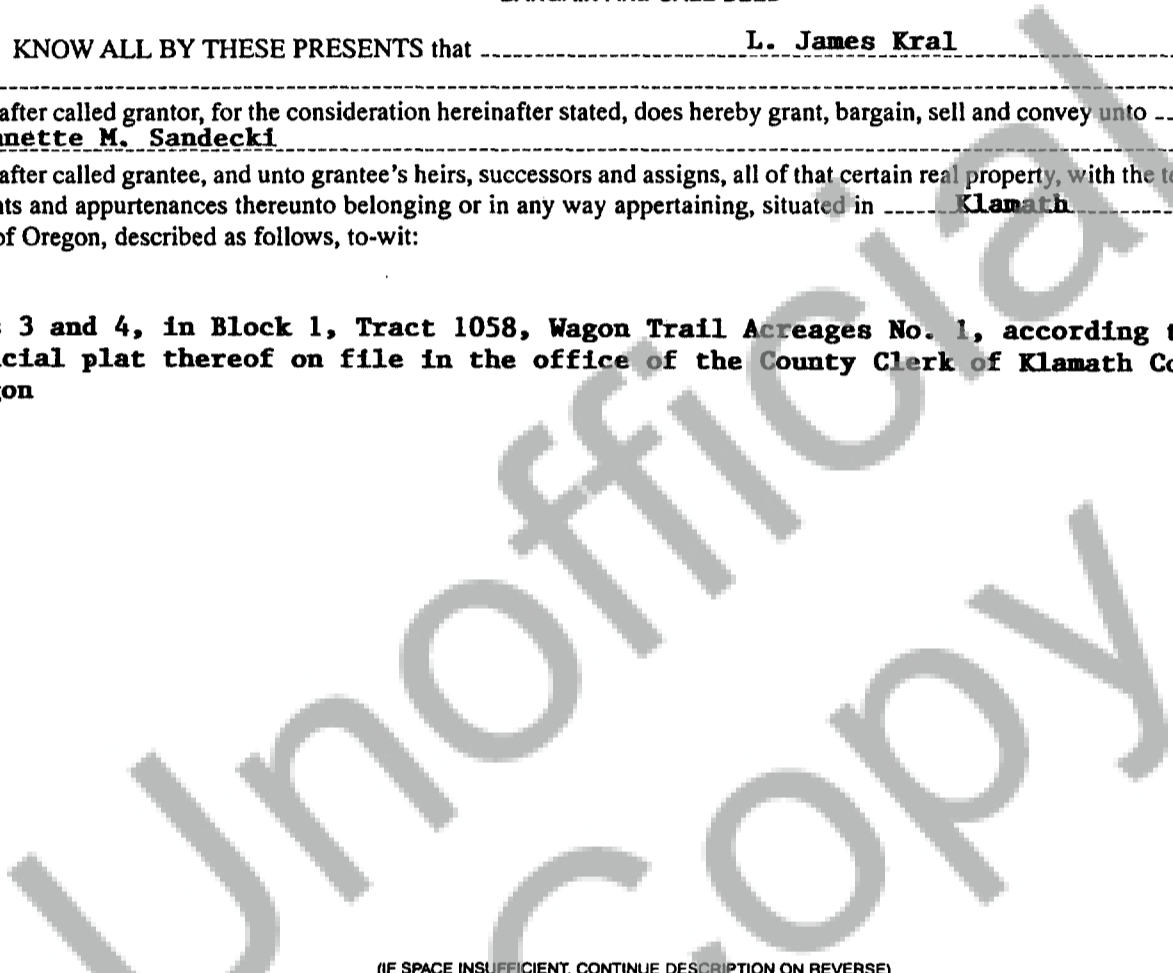
BARGAIN AND SALE DEED

KNOW ALL BY THESE PRESENTS that L. James Kral
