assigns, a permanent easement to construct and maintain slopes, upon the following described property:

A parcel of land lying in Lot 9, Block 5, NORTH CHEMULT, Klamath County, Oregon and Lot 7, Block 4, CHEMULT OREGON, Klamath County, Oregon and being a portion of that property described in that Warranty Deed to Alfred W. Pugh and Dorothy Pugh, recorded in Book M-84, Page 21382 of Klamath County Record of Deeds; the said parcel being that portion of said property lying Southerly of that property described in that Memorandum of Contract of Sale of Real Property to Daniel S. Miller and Alberta E. Miller, recorded in Book M-89, Page 3877 of Klamath County Record of Deeds and included in a strip of land 16 meters in width, lying on the Westerly side of the center line of the relocated The Dalles-California Highway which center line is described as follows:

Beginning at Engineer's center line Station 20+999.999, said station being 329.679 meters South and 103.539 meters West of the Northeast Corner of Section 20, Township 27 South, Range 8 East, W.M.; thence South 19° 09' 00" East 1547.387 meters to Engineer's center line Station 22+547.386.

ALSO that portion of Chemult Road vacated by that Order Of Vacation, recorded in Book 292, Page 494 of Klamath County Record of Deeds inuring to said Block 5 and said Lot 7 included in said strip of land.

The parcel of land to which this description applies contains 73 square meters, more or less, outside of the existing right of way.

IT IS UNDERSTOOD that the easement herein granted does not convey any right or interest in the above-described property, except as stated herein, nor prevent Grantor from the use of said property including the right to build additional buildings or structures therein; provided, however, that such use shall not be permitted to interfere with the rights herein granted or endanger the lateral support of the public way.

IT IS ALSO UNDERSTOOD that Grantee shall never be required to remove the slope materials placed by it on said property, nor shall Grantee be subject to any damages to Grantor and grantor's heirs, successors and assigns, by reason thereof, or by reason of any change of grade of the public way abutting on said property.
