DESCRIPTION

The following described real property situate in Klamath County, Oregon:

A Tract of land in the SW ¼ NE ¼ of Section 2, Township 39 South, Range 9 East of the Willamette Meridian, more Particularly described as follows:

Beginning at a point Northerly 30 feet and North 89°21' East along the Northerly right of way line of the Dalles-California Highway a distance of 156.6 feet from the iron pin which marks the center of Section 2, Township 39 South, Range 9 East of the Willamette Meridian, and which point is also the Southeast corner of the property Heretofore conveyed to A. L.
