## WARRANTY DEED

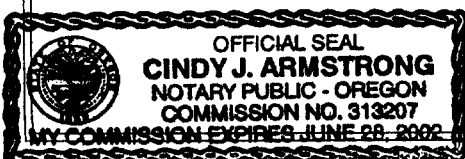
