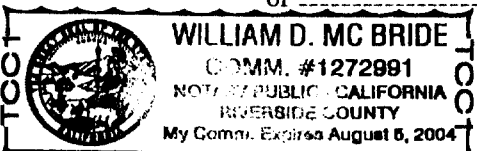

LEGAL DESCRIPTION

PARCEL 1:

TOWNSHIP 36 SOUTH, RANGE 10 EAST WILLAMETTE MERIDIAN, KLAMATH COUNTY, OREGON.

SECTION 14: BEGINNING AT THE OF CENTER OF SEC. 14 THENCE WEST 127' MORE OR LESS TO THE S.W.
