LEGAL DESCRIPTION DESCRIPTION

The following described real property situate in Klamath County, Oregon:

A parcel of land situated in the S ½ of SW ¼ of NW ¼ of Section 20, Township 39 South, Range 10 East of the Willamette Meridian, more particularly described as follows:

Commencing at the Southwest corner of the NW 1/2 of said Section 20; thence North 00°21'40" East along the West line of said Section 20, 301.29 feet; thence leaving said West line North 89°56'43" East 35.00 feet to the Easterly right of way line of the County Road and the point of beginning of this description; thence continuing North 89°56'43" East 1302.05 feet; thence South along the East line of said S 1/2 of SW 1/2 of SW 1/2 of NW 1/2 to the Southeast corner thereof; thence West along the South line of said S 1/2 of SW 1/2 of NW 1/2 to the Easterly right of way line of said County Road; thence North along the Easterly line of said County Road to the point of beginning of this description.

Commencing at a bolt at the intersection of the centerlines of Reeder Road and Short Road, county roads, and marking the Southwest corner of said NW ½; thence South 89°59'50" East along the South line of said NW ½, 30.00 feet to the Easterly right of way line of said Reeder Road; thence North 00°21'40" East along said right of way line, 158.56 feet to the point of beginning for this description; thence continuing North 00°21'40" East, along said right of way line, 142.76 feet; thence North 89°56'43" East, 1307.05 feet to a 5/8 inch iron pin; thence South 00°17'02" West along the East line of the SW ½ NW ½, 143.42 feet to a ½ inch iron pin; thence South 89°58'27" West 1307.24 feet to the point of beginning.
