EXHIBIT "A"  
LEGAL DESCRIPTION

12645

A strip of land 25 feet in width located in the NW1/4 NW1/4 of Section 18, Township 39 South, Range 10 East of the Willamette Meridian (being a portion of that parcel described on page 145 of Volume 342 of the deed records of Klamath County) being 12.5 feet in width on either side of the following described centerline:

Beginning at a point on the easterly right-of-way boundary of State Highway No. 39, as the same is presently located and constructed, from which the monument marking the Northwest corner of Section 18, Township 39 South, Range 10 East of the Willamette Meridian (as established by Recorded Survey No. 1018) bears West 30.0 feet and North 118.0 feet distant; thence North 34°19' East 106.5 feet, more or less, to a point on the southerly right-of-way boundary of the county road identified as "Keller Road" from which point the monument marking the Northwest corner of said Section 18 bears North 30.0 feet and West 90.1 feet, more or less, distant; together with the right of ingress and egress thereto for the purpose of construction, reconstruction, operation, and maintenance of a buried irrigation pipeline, and being subject to all rights-of-way and/or easements of record or apparent on the premises.
