## MODIFICATION OF DEED OF TRUST

THIS MODIFICATION OF DEED OF TRUST dated March 29, 2001, is made and executed between William L. Rudesill, whose address is 1165 Harbor Isles Blvd, Klamath Falls, OR 97601 ("Grantor") and South Valley Bank & Trust, Commercial Branch, P O Box 5210, Klamath Falls, OR 97601 ("Lender").

**DEED OF TRUST.** Lender and Grantor have entered into a Deed of Trust dated August 30, 1995 (the "Deed of Trust") which has been recorded in Klamath County, State of Oregon, as follows:

REAL PROPERTY DESCRIPTION. The Deed of Trust covers the following described real property located in Klamath County, State of Oregon:

PARCEL 1: Lot 47 in Block 1 of First Addition to Harbor Isles, Tract No. 1252, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon. Revise the interest Rate from a Variable rate to a Fixed rate of 10.00%. Revise payment schedule and Extend the Maturity Date to March 10, 2006. The Deed of Trust secures the "ORIGINAL" debt secured hereby and the restructured debt payment agreement of other obligations totaling the sum of \$439,808.89 plus interest, as evidenced by a promissory note from Grantor to Lender dated March 10, 2000.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

The word "NOTE" means the Note executed by Grantor in the principal amount of \$346,920.23 PLUS Previous Obligation of \$92,950.89, dated March 29, 2000, TOGETHER with all renewals of, extensions of, modifications of, refinancings of, consolidations of, and substitutions for the note or credit agreement.
