## **COMMUNICATIONS FACILITIES EASEMENT**

OWNER'S MICHAELE. SILVA + ROBERTA SILVA HAW
(hereinalter referred to as "Grantor", nereby grants to CENTURYTEL OF EASTERN OREGON, INC.
dba CENTURYTEL, its successors and assigns, (hereinafter referred to as CenturyTel) a perpetual non-
exclusive easement and right to construct, operate and maintain underground telephone and
communications facilities or systems, together with all necessary wires and fixtures incidental thereto, under and upon the following described property: A PARCEL OF LAND LOCATED IN
THE NILL VI SELVI OF SECTION 3 THAT IN COLORATED IN
THE NW 14 SE 14 OF SECTION 3 TWN 415 RNG/Z E TAXLOT 1400 IN KLAMATH COUNTY OREGON AND RECORDED IN THE KLAMATH
PARTICULARLY DESCRIBED AS FOLLOWS: STARTING AT THE NN CORNER OF TAX LOT 1400 CORNER OF TAX LOT 1400 CORNER OF TAX LOT 1400.
Situated in the County of KLAMATH , Oregon. This easement shall also include the right to
excavate for, construct, maintain, inspect, alter, repair, operate, change and remove a Communications Site in the location generally shown on Exhibit "A", attached hereto and made part hereof, including, but not limited to, the right to place communications equipment, cabinets and other equipment enclosures, covers and other structures, security fences, foundations, electrical ground systems, lighting and security systems, commercial power and other utility facilities necessary or convenient to the construction, operation or maintenance of the site, and all cables, wires, poles, guys, anchors and other equipment
appurtenant thereto.
CenturyTel shall maintain the Communications Site in a neat and orderly manner, and shall be responsible for any damage to adjacent lands of Grantor, caused directly by its exercise of the rights herein granted. Said adjacent lands of Grantor shall be restored, as nearly as reasonably possible, to prior condition in a workmanlike manner, provided, however, that CenturyTel shall have the right to clear and keep cleared all trees, brush or other obstructions, whether located within the Communications Site or on adjacent lands of Grantor, which may interfere with or threaten to interfere with the operation or maintenance of the Communications Site.
Grantor hereby covenants and agrees to allow other utilities to serve the Communications Site across adjacent lands of Grantor and further covenant and agree to execute whatever reasonable easement grants that may be required by such utilities or CenturyTel for this purpose.
This easement grant shall extend to and be binding upon the heirs, executors, administrators, successors and assigns of the parties hereto.
