CORRECTION DEED OF POWER LINE
AND RIGHT OF WAY EASEMENT

THIS INDENTURE, Made the 5th day of May,
1961, between CROWN ZELLERBACH CORPORATION, a Nevada corporation,
hereinafter called the "Grantor", and MIDSTATE ELECTRIC COOPERA-
TIVE, INC., Box 96 LaPine, Oregon, hereinafter called the "Grantee";

W I T N E S S E T H:

considerations, the receipt whereof is hereby acknowledged does
hereby grant and convey an easement unto the said Grantee over
