THIS INDENTURE, Made this 7th day of June, 2001, between Valerie T. Auerbach, hereinafter called trustee, and Forest Products Federal Credit Union, hereinafter called the second party. The true and actual consideration for this conveyance is \$71,765.11.

WITNESSETH:

RECITALS: Reference is made to that Trust Deed dated June 24, 1997, by Robert N. Griffith and Amy L. Griffith, as grantors, to Aspen Title & Escrow, as trustee, in favor of Forest Products Federal Credit Union, as beneficiary, recorded on June 27, 1997, in Vol. M97, Page 20095, in the mortgage records of Klamath County, Oregon.
