THIS AMENDMENT, made and entered into this 30<sup>th</sup> day of May, 2001, by and between J-SPEAR RANCH CO., hereinafter referred to as GRANTOR, and the STATE OF OREGON, acting by and through its Board of Forestry, hereinafter referred to as GRANTEE;

WHEREAS, GRANTOR granted an easement to GRANTEE dated January 31, 1994 and recorded February 10, 1994 in Volume M94, Page 4627, Deed Records of Klamath County, Oregon;

WHEREAS, GRANTOR and GRANTEE desire to amend said easement in the manner hereinafter set forth;

NOW, THEREFORE, the parties hereto, do agree as follows:

1. The above-described easement is hereby amended to include an additional existing road located in the South half of the Northwest quarter of the Southeast quarter (S $\frac{1}{2}$ NW $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section 34, Township 32 South, Range 7 East, Willamette Meridian, Klamath County, Oregon, as shown on the attached Exhibit "A".
2. That, except as amended, all the terms and conditions of said easement shall be and remain in full force and effect.



Klamath County, Oregon


