**Full Rights of Survivorship.

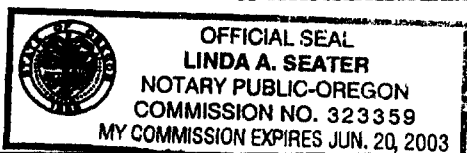
